Audition Information:

Vocal auditions for *Legally Blonde* will take place on **Tuesday, January 10** starting at **3:00** in the band room. Dance auditions will take place on **Wednesday, January 11** at **3:00** in the all-purpose room. Please wear comfortable clothes for your dance audition. You **MUST** attend both a vocal audition and a dance audition to be considered for this show. Please return the attached audition contract to Mrs. Barth or the Main Office.

You must sign up for an audition time in the Main Office.

Audition Requirements:

Auditions are open to all Central Middle School students. Please note that all students who audition will be considered for this production. Requirements for auditioning are as follows:

1. The attached audition contract **MUST** be signed and returned to Mrs. Barth or the Main Office **before you may sign** up to audition.
2. Audition songs will be posted on Mrs. Barth's website. Please pick one song and prepare it for your audition.
3. Students will audition in groups of five.
4. Everyone will be asked to sing. Everyone will be asked to dance. Don't doubt your abilities! Just try your best.

Callback Information:

Callbacks will take place on **Thursday, January 12** at **3:00** in the band room. The callback list will be posted on Mrs. Barth's website the night before. Receiving a callback **DOES NOT** mean a student has been cast. It simply means we must see the student perform again in order to make a decision.

Conflicts:

To put on a quality production, it is imperative that the entire cast be present and on time for rehearsals. Rehearsals will typically be held **Monday, Wednesday, and Friday** from **3:00 to 4:45** starting Wednesday, **January 18**. Tech rehearsals will take place **March 20, 21, and 22**. You must discuss with your parents and list any events or commitments that may conflict with rehearsal. This includes doctor's appointments, lessons, vacations, or anything that will prevent you from being present at rehearsal. **Missing rehearsal without letting us know in advance could result in being cut from the show. There will be no absences during tech rehearsals.**

4. Students who are cast in the show are required to pay a \$55 participation fee at the beginning of the rehearsal process. This will cover one cast t-shirt per student. Additional t-shirts can be ordered upon request. Checks must be made out to **Central School Student Funds**.
